## THE ISSUES

- 3. The Director of the Alabama Ethics Commission, who directs the day to day work of the Commission Staff is also an attorney. Prior to becoming Director he was appointed as one of three Trustees that administers the Mabel Amos Memorial Fund, a scholarship trust created by her Will which also demands that two members of Albritton's Law Firm in Andalusia, Alabama, sit as Trustees. Alabama State Ethics Commission Director Thomas Albritton continues to serve as a Trustee.
- 4. The Trust document has two simple Ethical Provisions: "The Trustee shall not engage in any self-dealing as defined in Section 4941(d), and shall not make any taxable expenditures as defined in Section 5489", referring to the Internal Revenue Code.
- 5. Director Thomas Albritton's children received scholarships from the Mabel Amos Memorial Fund, in violation of sections 4941 (d) and 5489.

## **ALLEGATIONS**

7. Director Thomas Albritton has stated publicly that he abstained from any votes related to scholarships awarded to his children. This does little to negate the violation of the Trust related to Internal Revenue Code 4941(d) and 5489.
